Existing Control Measures
1. If products go on skin: Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning

2. EYE PROTECTION MUST BE WORN If product is accidentally splashed into the eyes. Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination
3. If product is ingested: Wash out mouth with water. Do not induce vomiting. Give 1 cup of water to drink every 10 minutes. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in recovery position. Transfer to hospital asap
4. If product inhaled Remove casualty from exposure ensure one's own safety whilst doing so.If unconscious & breathing is OK, place in recovery position. If conscious, ensure casualty sits or lies down.If breathing becomes bubbly,have casualty sit & provide oxygen if available.Transfer to hospital asap
5. Cleaning chemicals are not mixed. All staff to Follow instructions on container / packaging
6. COSHH assessments communicated to all relevant staff
7. GLOVES WORN AT ALL TIMES. All articles of personal protective wear should be maintained and checked before and after use in all instances.
8. Spillages prevented. Products in containers have their lids in place and secure when not in use
9. Exposure Times Controlled as per manufacturer's instructions. Product used in ventilated area
10. Keep away from sources of ignition. Substances not used/stored near naked flames or points of ignition/high temperatures
11. All employees receive induction training upon commencement with the Company
