<b>Existing Control Measures</b>
1. Avoid inhalation of product by following manufacturer's instructions for use IF INHALED: remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.
2. If product gets on skin: Wash skin thoroughly with soap and water. Remove contaminated clothing. Get medical attention promptly if symptoms occur after washing.
3. Wear protective eye wear if risk of splashing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor/physician.

4. Follow manufacturer's instructions: IF ACCIDENTALLY SWALLOWED: rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor/physician.
5. Cleaning chemicals are not mixed. All staff to Follow instructions on container / packaging
6. COSHH assessments communicated to all relevant staff
7. GLOVES WORN AT ALL TIMES. All articles of personal protective wear should be maintained and checked before and after use in all instances.
8. Spillages prevented. Products in containers have their lids in place and secure when not in use
9. Exposure Times Controlled as per manufacturer's instructions. Product used in ventilated area
10. Keep away from sources of ignition. Substances not used/stored near naked flames or points of ignition/high temperatures
11. All employees receive induction training upon commencement with the Company
