OF WORK	2.	Place warning signs in prominent place outside the lift to prevent unauthorised access.

	3.	Key to be obtained from the Manager to switch off the lift before cleaning commences.
	4.	Immobilise lift
	5.	Clean the inside of the lift (walls, panels, mirrors) using
		approved equipment and solutions.
	6.	Finish off with vacuuming, if carpeted. Ensure that equipment is plugged correctly and that the lead is long enough to allow the process. Cable for the vacuum is placed over the shoulder and vacuuming commences.
	7.	If there are hard floors, keep the mop bucket outside the lift and step outside the lift to use the wringer returning to the lift, to mop. Ensure hard floors are dry before removing signage and mobilising lift.
	8.	When vacuuming/mopping and cleaning are completed ensure that all equipment is removed from lift and floors are completely dry.
	9.	Clean lift doors. If stainless steel, ensure the cleaning product is sprayed onto the cleaning cloth and not directly on to the surface being cleaned. Ensure any overspray is immediately cleaned up to prevent slips, trips, and falls.
	10.	Ensure attention is paid to detail and into corners and edges, finally buff with a clean cloth.
	11.	Mobilise lift into service and continue to next lift. Repeat until all lifts have been cleaned.
	12.	Ensure area is safe before removing safety signs
	13.	Take vacuum cleaner and cleaning materials back to cleaning
		cupboard and ensure they are stored safely.
	14.	Take the key back to the Manager and report any problems found.
