MATERIALS & EQUIPMENT	Vacuum cleaner, signage, vacuum cleaner bags, black refuse bags, dustpan, and brush				
SCOPE OF WORKS	Suction cleaning in various locations				
SAFE SEQUENCE OF WORK	 Check electrical equipment particularly plugs and cable for safety prior to commencement of task Check vacuum cleaner bag has been emptied. Do not plug in machine until it has been reassembled. Check PAT up to date, Display warning signage. Plug the vacuum cleaner into an appropriate socket, taking care not to remove plugs from live equipment. Do not allow cable to become taut at ankle height. If there are no sockets within the carpeted area "extension" leads to be used, taking care to work within approximately two thirds of the vacuum's cable length. If an extension lead is used "Identify It" (Trailing cables signage) as necessary to avoid persons from tripping. If the carpeted area extends over more than one floor or steps, the cleaners are instructed to use lifts, if available, or take reasonable care when carrying vacuum cleaners between floors or up and down steps. When moving upright vacuum cleaners, limit the carrying, to a minimum. All waste from the vacuum cleaners is deposited into black plastic refuse bags which are removed from the work area to the rubbish collection point, at the end of the shift. Do not allow bags to become too full as this can cause overheating. On completion the cleaner to ensure that all furniture etc is returned to the respective areas, not blocking any gangways and do not constitute a hazard. Signage should remain in place until task complete and cable recoiled. Risk Assess.
